### SECTION 2 - HAZARDS IDENTIFICATION

#### Emergency Overview

Aluminum/Gray. Non-sag gunnable paste. May cause nausea, headaches, and dizziness. May cause drowsiness, weakness, and fatigue. May cause moderate irritation to the respiratory system. Leave area to breathe fresh air. Avoid further overexposure. If symptoms persist, get medical attention.
