### **RANDALL KORACH NAMED PRESIDENT OF RPM BUILDING SOLUTIONS GROUP**

Over the years, he has served on the board of directors of nonprofit organizations, including the Montefiore Home for the Aged, Council Gardens, Suburban Temple, Shaker Heights Youth Center, Menorah Park, Center for Families and Children, LifeBanc and Business Volunteers Unlimited. Jeff also has served on the President's Council at Tulane University, his alma mater. He and his wife, Sue Ellen, reside in Shaker Heights, Ohio.
